The hearing will be conducted before the Veterinary Medical Board, Department of Consumer Affairs and an administrative law judge of the Office of Administrative Hearings, who will preside over the Petition for Reinstatement matter.

If you object to the petition being heard by videoconference, you must notify the presiding officer within ten (10) days after this notice is served on you. Failure to notify the presiding officer within ten (10) days will deprive you of a change in the place of hearing.

You may be present at the hearing. You have the right to be represented by an attorney at your own expense. You are not entitled to the appointment of an attorney to represent you at public expense. INTREPRETER: Pursuant to section 11435.20 of the Government Code, the hearing shall be conducted in English language. If a party or party's witness does not proficiently speak or understand the English language and before commencement of the hearing requests language

assistance, an agency subject to the language assistance requirement in section 11435.15 of the Government Code shall provide a certified interpreter or an interpreter approved by the administrative law judge conducting the proceedings. The cost of providing the interpreter shall be paid by the agency having jurisdiction over the matter if the administrative law judge or hearing officer so directs, otherwise by the party for whom the interpreter is provided. If you or a witness requires the assistance of an interpreter, ample advance notice of this fact should be given to the Office of Administrative Hearings so that appropriate arrangements can be made.

CONTINUANCES: Under section 11524 of the Government Code, the agency may grant a continuance, but when an administrative law judge of the Office of Administrative Hearings has been assigned to the hearing, no continuance may be granted except by him or her or by the presiding judge for good cause. When seeking a continuance, a party shall apply for the continuance within 10 working days following the time the party discovered or reasonably should have discovered the event or occurrence which establishes good cause for the continuance. A continuance may be granted for good cause after the 10 working days have lapsed only if the party seeking the continuance is not responsible for and has made a good faith effort to prevent the condition or even establishing the good cause.

Esteemed Board Members,

My name is Elaine Marie Gawlik. This is my narrative statement for petition to reinstate my California veterinary license, No. VET 10507, revoked by default decision effective November 23, 2016. My veterinary license was placed on probation August 23, 2012 for convictions of alcohol related misdemeanors and failure to disclose convictions when renewing my license. I violated the terms of probation when I was convicted of D.U.I. in June 2015.

I was bitten on my left hand and thumb by a seizing patient in October 2013. The ensuing infection was so severe I was unable to work and on months of intravenous antibiotics via PICC line both hospitalized and at home. The damage caused almost complete loss of function in my left thumb, and I was in physical therapy several times weekly for over a year. As my thumb was slowly improving, I suffered a complete tear to my right rotator cuff, my dominant arm, and was unable to lift it to my waist.

By early 2015 I was in a very dark place; spiritually, physically, and emotionally. I was no longer able to work at the job I so cherished. I was charged with DUI for sleeping in my car heavily intoxicated with the keys in my possession. This brought me to a bottom I needed to hit. The conviction was disclosed to the Board and started a process of revocation.

2 surgeries to repair my right rotator cuff in 2016 were unsuccessful 6 months apart. I could not lift my right arm to my waist, and although function of my left hand and thumb was greatly regained, it as looking as though I would never return to the practice of veterinary medicine. I had not practiced since the bite in 2013.

When the letter came from the Veterinary Medical Board in 2016 seeking revocation of my veterinary license, I simply gave up. I did not fight. It took another year to have my right shoulder repaired via reverse total shoulder replacement in late 2017. I finally had function of both hands and arms, at the same time.

My sobrlety today is the priority in my life. I have learned through some very hard lessons that anything I place in front of it I can lose. I attend Alcoholics Anonymous (AA) meetings daily. I consistently and rigorously work AA's 12 steps and practice those principles in each area of my life. I am fully invested in my sobriety and am very active

in service work within AA Itself. I speak on AA panels that we take into hospitals, jails, and institutions, and have several commitments at my regular meetings (treasurer, secretary).

Last year I helped organize and attended the 2019 San Fernando Valley AA Convention, an annual gathering of 2000+ recovering alcoholics, and am doing so again this year for 2020. I reside in a sober living home, the Hope House, where I have lived since November of 2017.

My sister and I are caring for our mother, 83, who is quickly declining in Alzheimer's disease. Our Dad is 83 and has health problems. The difference for me today is that I can help. I GET to help. I am so blessed to have the fellowship of AA surrounding me today. What time I wasted thinking I could stay sober on my own. My life has been given back to me because I have embraced the program of Alcoholics Anonymous.

My criminal probation was terminated early (October 2018) and the accompanying DUI conviction was also expunged from my record.

My career means the world to me. I am now presented with the opportunity to start again. Veterinary Medicine is and has been my passion since I was a teen. I graduated from High School as Valedictorian, went directly to college and graduated from Cal Poly San Luis Obispo Summa Cum Laude in 1985. I graduated with honors from UC Davis School of Veterinary Medicine in 1989 when I was 25 years old. I have worked continuously in small animal private practice since my graduation until my injury in 10/2013. I enjoy the patients, client education, and I am a dedicated learner.

I take continuing education seriously and constantly seek to keep up to date with ever evolving diagnostics and treatment protocols. I have completed over 60 units of R.A.C.E. approved continuing education over the past 1 ½ years. I utilize Veterinary Information Network daily, as well as read DVM 360 regularly.

It is both humbling and thrilling to be working once again in veterinary medicine, albeit in a technical capacity. After healing from my final shoulder surgery, I returned to Warner Center Pet Clinic in 02/2018 as a veterinary assistant. What I was sure was lost is being found. I have been offered a position there as an associate veterinarian when my license is reinstated. Their belief in me is invaluable.

Today drinking is no longer an option. I deal with life on life's terms and have the tools and support with which to do so. Sober. Thank you for your consideration.

Dr Gawlik and I have had many conversations regarding her license revocation. She has been open and honest about the how's and why's this occurred. She has taken full responsibility for her actions and her alcoholism and makes no excuses. She has worked



PROPOSED DECISION

Howard W. Cohen, Administrative Law Judge of the Office of Administrative Hearings, heard this matter in Los Angeles on May 8, 2012.

Randy Mailman, Deputy Attorney General, appeared on behalf of complainant Susan M. Geranen, Executive Officer of the Veterinary Medical Board (Board), Department of Consumer Affairs, State of California.

Grace E. Ayers, attorney at law, represented respondent.

Oral and documentary evidence was received. The record was closed and the matter was submitted for decision on May 8, 2012.

FACTUAL FINDINGS

Jurisdiction and Parties

1. Complainant filed the Accusation in her official capacity. Respondent timely filed a Notice of Defense.

2. The Board issued license number 10507 to respondent on July 6, 1989. The license has been in full force and effect at all times relevant to this proceeding and is scheduled to expire on June 30, 2013, unless renewed. The Board has previously issued two citations to respondent, on May 28, 2002, and on February 23, 2004, and ordered respondent to pay a fine of \$501 for each citation.

Respondent's Criminal Convictions

3. On November 17, 2010, in the Superior Court of California, Los Angeles County, Case No. OVY04715, respondent pled nolo contendere and was convicted of violating Vehicle Code section 23152, subdivision (b) (driving with greater than .08 percent blood alcohol), a misdemeanor. Respondent admitted to her August and November 2002 convictions for violation of Vehicle Code sections 23152, subdivisions (a) and (b), respectively. The court found a factual basis for and accepted the plea. The court suspended imposition of sentence and placed respondent on summary probation for a period of 60 months on terms and conditions including that she serve 180 days in Los Angeles County Jail, wear a SCRAM bracelet until her day of surrender for incarceration, pay fines, fees, and assessments totaling \$2,299, enroll within 21 days in an SB 38 alcohol treatment program. participate in an 18-month treatment or counseling program as directed, and install an ignition interlock device on her vehicles. The court revoked respondent's driver's license for three years and disallowed the issuance of a restricted license, finding that respondent poses a traffic safety or public safety risk and is a habitual traffic offender. On January 7, 2011, respondent surrendered for 180 days of County Jail and an additional 16 days of County Jail in lieu of certain fines.

4. The facts and circumstances underlying the conviction are that, on September 10, 2010, respondent crashed into two parked cars while operating her vehicle with a blood alcohol content of 0.27 to 0.31 percent.

5. On June 13, 2007, in the Superior Court of California, Yuba County, Case No. CRM07-74, respondent pled guilty and was convicted of violating Penal Code section 647, subdivision (f) (disorderly conduct—unable to exercise care for her own safety or the safety of others by reason of being under the influence of intoxicating liquor), a misdemeanor. The court suspended imposition of sentence and placed respondent on summary probation for a period of 24 months on terms and conditions including that she pay fines and fees totaling \$315, abstain from alcohol use, and comply with all directives of the Board.

6. The facts and circumstances underlying the conviction are that, on January 16, 2007, respondent, while intoxicated, rode her bicycle to the store to buy vodka, leaving her infant daughter at home unattended. Respondent testified that "I had bad judgment."

7. On November 20, 2002, in the Superior Court of California, County of Inyo, Case No. 231784, respondent pled no contest and was convicted of violating Vehicle Code section 23152, subdivision (b) (driving with greater than .08 percent blood alcohol), a misdemeanor. The court suspended imposition of sentence and placed respondent on summary probation for a period of 36 months on terms and conditions including that she serve 120 days in jail, which can be satisfied by a residential treatment program of comparable duration, have her driver's license revoked for three years, pay fines and fees totaling \$1,670, enroll in and successfully complete an SB 38 alcohol treatment program, and abstain from alcohol use. 8. On August 9, 2002, in the Superior Court of California, County of Sacramento, Case No. 2T00145, respondent pled nolo contendere and was convicted of violating Vehicle Code section 23152, subdivision (a) (driving with greater than .08 percent blood alcohol), a misdemeanor. The court found a factual basis for and accepted the plea. The court suspended imposition of sentence and placed respondent on informal probation for a period of four years on terms and conditions including that she pay fines and fees totaling \$1,477, serve 10 days in county jail, and have her driver's license restricted.

9. Probation for respondent's November 2010 conviction is scheduled to end in November 2015. Respondent testified that she served jail time in lieu of most of the fines assessed with respect to her November 2010 conviction, and that she paid the balance in early 2011. She has not yet completed the court-ordered alcohol program. None of her convictions has been expunged.

Respondent's License Renewal Application

10. On June 7, 2007, respondent submitted a License Renewal Application to the Board in order to renew her veterinary license through June 30, 2009. Respondent signed the application under penalty of perjury. The application asked, "Since you last renewed your license, have you been convicted or pled nolo contendere to a felony or misdemeanor . . . ?" Respondent put a check next to the response, "No." (Ex. 11.) The response was accurate.

11. Six days later, on June 13, 2007, respondent was convicted of a misdemeanor. (Factual Finding 5.) She did not immediately report the conviction to the Board; rather, she testified, she did not disclose it until "much later," when she received an inquiry from the Board.

12. On July 1, 2009, respondent submitted another License Renewal Application to the Board in order to renew her veterinary license through June 30, 2011. Respondent signed the application under penalty of perjury. The application asked, "Since you last renewed your license, have you been convicted or pled nolo contendere to a felony or misdemeanor ...?" Respondent put a check next to the response, "No." (Ex. 11.) That response was not accurate; respondent had, in fact, been convicted of a misdemeanor after her last license renewal. (Factual Findings 5, 11.)

13. In mitigation, respondent submitted the July 2009 application one year before her sobriety date, the date of the arrest leading to her most recent conviction. (Factual Finding 14, below.) But rather than rely on that fact to explain the non-disclosure, respondent testified unconvincingly that she did not think she had to check the "Yes" response because she had already disclosed the conviction to the Board. (See Factual Finding 11.)

Respondent's Rehabilitation

14. Respondent is 48 years old. She testified that she is an alcoholic, that she was a binge vodka drinker, and that her drinking problem began in the late 1990s. She testified that she has been sober since September 10, 2010, the date of her last arrest, that she has not

drunk any alcohol since that date, and that she works towards sobriety every day. She attends AA meetings every week as a condition of her probation, in addition to attending a driver safety program. She has had a sponsor at AA since September 10, 2010. She last completed the 12 steps eight or nine months ago, and has started over. She was also evaluated by a substance abuse counselor at the court-ordered driver safety program. She currently sees a psychiatrist for individual sessions through Kaiser Permanente to address her alcohol problem and depression. She testified that she takes Acamprosate to reduce her craving for alcohol and she takes Floxacin for depression. She requested the prescription for Acamprosate because she was having difficulty within her alcohol program and did not want to slip. She is grateful that she has the resources to pay for the counseling and medication. She pays \$659 per month in health insurance premiums; if she loses her job, she testified, she will not be able to afford to continue seeing her psychiatrist. She did not submit the testimony of any health care professional or any documentary evidence of the progress or prognosis of her psychiatric and medical treatment for alcoholism. When asked at hearing whether she had assessed the cause or trigger for her excessive drinking, she testified, "I wish I could answer that. I'm an alcoholic."

15. Respondent acknowledges her past and testified that she has done things she is not proud of. She testified that her past does not define her, it directs her toward recovery. She tries to be a good mother to her daughter, and believes she is a great veterinarian. She lives at her parents' house with her parents and her daughter; her daughter's father, who was present at hearing, helps financially. She testified that "there's probably a wake of disaster behind me," but she is doing her best to clean it up and to keep doing her job in a sober manner.

16. Since January 1, 2012, respondent has been employed as a relief veterinarian with All Creatures Animal Emergency Center (All Creatures). She disclosed her convictions and this administrative action to All Creatures. She expected her job with them to become a long-term full-time position, but it did not. Since April 15, 2012, respondent has also been employed at Beverly Oaks Pet Hospital (Beverly Oaks) on a full-time basis as a veterinarian with a general and emergency practice. She has not disclosed her convictions or this administrative action to Beverly Oaks because she is worried about the effect of the disclosure on her employment there. She has never been disciplined by her employers. She is very happy in her work; she has never worked at anything else since she graduated from college. As a teenager, she volunteered for a veterinarian, and become employed by that veterinarian in high school. She plans to remain employed as a veterinarian, doing what she loves to do.

17. Respondent submitted a letter from her AA sponsor, who wrote that respondent "is committed to her sobriety," that respondent is dedicated to her work and her daughter, and that respondent knows that "without sobriety, neither will be secure." (Ex. A.)

18. Respondent also submitted two character reference letters. One letter is from the administrative director at All Creatures, who wrote that respondent is "compassionate, organized, efficient, extremely competent," and "a wonderful teacher to the staff." (Ex. C.)

The other letter, addressed "Dear Prospective Veterinary Employer," is from Robert A. Richardson, DVM, who wrote to recommend respondent; Dr. Richardson worked with respondent in the 1990s, and found her to be diligent, organized, and "remarkably capable." (Ex. E.)

19. Respondent also submitted a letter from the counselor at her driver safety program, who wrote that she is "one of our most applied students" who "always makes great contributions" to discussions and who is "commited [*sic*] to completing her program in good standing and her progress reports demonstrate it." (Ex. D.)

Costs of Enforcement

20. The Board incurred reasonable costs of enforcement, consisting of Attorney General fees, in the amount of \$2,260.

LEGAL CONCLUSIONS

1. The Board may suspend or revoke a license to practice veterinary medicine on any of the grounds set forth in Business and Professions Code section 4883. (Bus. & Prof. Code, § 4875.) Those grounds include:

a. Conviction of a crime substantially related to the qualifications, functions, or duties of veterinary medicine (§ 4883, subd. (a));¹

b. Unprofessional conduct, which includes the use of alcohol to the extent it is dangerous or injurious to any other person or to the public, and which also includes the conviction of more than one misdemeanor or any felony involving the use of alcohol (§ 4883, subd. (g)); and

c. Fraud, misrepresentation, or deception in obtaining the license or registration. (§ 4883, subd. (k).)

2. The Board bears the burden of proof in this matter as it seeks to discipline respondent's license. (*Bley v. Board of Dental Examiners* (1932) 120 Cal.App. 426, 430-431.) The standard of proof to establish the charging allegations in this case is "clear and

¹ A crime or act is substantially related to the qualifications, functions, or duties of a licensed veterinarian "if to a substantial degree it evidences present or potential unfitness of [the licensee] to perform the functions authorized by his or her license in a manner consistent with the public health, safety or welfare." (Cal. Code Regs., tit. 16, § 2040.) A conviction may form the basis for suspending or revoking a license if the criminal conduct underlying the conviction bears a substantial relationship to the qualifications, functions, and duties of the license. (*Morrison v. State Board of Education* (1969) 1 Cal.3d 214; *Griffiths v. Superior Court* (2002) 96 Cal.App.4th 757, 769-770.)

convincing" evidence. (*Ettinger v. Board of Medical Quality Assurance* (1982) 135 Cal.App.3d 853.) This means that the burden rests with complainant to offer proof that is clear, explicit, and unequivocal, "so clear as to leave no substantial doubt; sufficiently strong to command the unhesitating assent of every reasonable mind. [Citations omitted.]" (*In re Marriage of Weaver* (1990) 224 Cal.App.3d 478, 487.)

3. Cause exists to suspend or revoke respondent's license under section 4883, subdivision (a), by reason of Factual Findings 3 through 9.

4. Cause exists to suspend or revoke respondent's license under section 4883, subdivision (g), in that respondent's four convictions for four separate alcohol-related offenses within the past 10 years demonstrate unprofessional conduct, by reason of Factual Findings 3 through 9.

5. Cause exists to suspend or revoke respondent's license under section 4883, subdivision (k), for providing an answer on her license renewal application that was false and known to respondent to be false, by reason of Factual Findings 10 through 13.

6. California Code of Regulations, title 16, section 2041, subdivision (b), provides that when the Board is considering suspending or revoking a license on the ground that the licensee has been convicted of a crime, and is evaluating the licensee's rehabilitation and eligibility for a license, the following criteria are pertinent:

(1) Nature and severity of the act(s) or offense(s);

(2) Total criminal record;

(3) The time that has elapsed since commission of the act(s) or offense(s);

(4) Whether the licensee has complied with any terms of parole, probation, restitution or any other sanctions lawfully imposed against the licensee;

(5) If applicable, evidence of expungement proceedings pursuant to Section 1203.4 of the Penal Code;

(6) Evidence, if any, of rehabilitation submitted by the licensee.

7. The Board has issued disciplinary guidelines to assist in the discipline of a license. Those "Veterinary Medical Board Disciplinary Guidelines, May 2002 Edition" (Guidelines) are incorporated by reference at California Code of Regulations, title 16, section 2006. The Guidelines provide that, for conviction of a substantially-related crime, rehabilitation measures may include pro bono services, specific training in areas of weakness, full restitution to persons harmed by the respondent, completion of treatment or other conditions of probation ordered by the court, and full compliance with all laws since

the date of the criminal act. "More severe penalties are appropriate if the criminal act threatened the life of an animal, there was more than one offense, there have been no or very few rehabilitation efforts, and there were no mitigating circumstances at the time the offenses were committed."

8. Considering all of the circumstances and the factors found at California Code of Regulations, title 16, section 2041, subdivision (b), as well as the Guidelines, respondent has not established sufficient rehabilitation to demonstrate that, without appropriate terms and conditions of probation, she will be able to practice in a manner that does not create potential harm to the public and that is consistent with the public health, safety, or welfare. Respondent has had four alcohol-related convictions over the past 10 years, including one as recently as 18 months ago. The fact that respondent will not complete probation for the most recent conviction until November 2015, and the fact that she has not completed the courtordered alcohol program, means that she will not be able to fully demonstrate rehabilitation for at least another three years. (See In re Gossage (2000) 23 Cal.4th 1080, 1099 [little weight placed on fact that licensee has engaged in good behavior while on probation].) Respondent did not demonstrate an especially high degree of self-awareness, stating that she does not know, even after her driver safety program sessions, psychiatry sessions, and AA meetings, what triggers her binge drinking. She provided no documentation from her psychiatrist regarding her prognosis or the effectiveness of the medications she takes. She was dishonest on her 2009 license renewal application and was not entirely forthcoming about that at hearing. And she has failed to inform her employer of her criminal record because she fears losing her job. On the other hand, respondent has been licensed for almost 23 years, during which time she has received only two citations from the Board and has never been disciplined by her employers. It is clear from the evidence that she is devoted to the practice of veterinary medicine and has been since she was a teenager. Although respondent's alcoholism has the continuing potential to result in harm to the patients she sees in her veterinary practice, there is no evidence that it has caused actual harm. Respondent has been sober for nearly two years; when she thought she might revert to drinking, she sought appropriate medical attention. (Factual Findings 3-19.)

9. These facts are of sufficient weight to warrant a 60-day suspension of respondent's license and five years of probation in order to protect the public and respondent's patients. This should be sufficient to satisfy the statutes relating to licensing of professions generally, which are designed to protect the public from dishonest, untruthful, and disreputable licensees. (*Arneson v. Fox* (1980) 28 Cal.3d 440, 451.) Proceedings to discipline a license are conducted to protect the public, not to punish. (*Camacho v. Youde* (1979) 95 Cal.App.3d 161, 165); see also *Fahmy v. Medical Bd. of California* (1995) 38 Cal.App.4th 810, 817.)

10. Reasonable costs of investigation and prosecution can be recovered under Business and Professions Code section 125.3. The amount of costs to be recovered from respondent is therefore \$2,260. (See Factual Finding 18.)

<u>ORDER</u>

All licenses and licensing rights of respondent Elaine Marie Gawlik, also known as Elaine M. Nesbitt, to practice veterinary medicine in California, including license number 10507, are revoked. The revocation is stayed; respondent's license shall be suspended for a period of 60 days, after which respondent shall be placed on five years' probation on the following terms and conditions:

1. OBEY ALL LAWS

Respondent shall obey all federal and state laws and regulations substantially related to the practice of veterinary medicine.

2. QUARTERLY REPORTS AND INTERVIEWS

Respondent shall report quarterly to the Board or its designee, under penalty of perjury, on forms provided by the Board, stating whether there has been compliance with all terms and conditions of probation. In addition, the Board at its discretion may request additional inperson reports of the probationary terms and conditions. If the final written quarterly report is not made as directed, the period of probation shall be extended until such time as the final report is received by the Board. Respondent shall make available all patient records, hospital records, books, logs, and other documents to the Board, upon request.

3. COOPERATION WITH PROBATION SURVEILLANCE

Respondent shall comply with the Board's probation surveillance program.

4. NO PRECEPTORSHIPS OR SUPERVISION OF INTERNS

Respondent shall not supervise a registered intern and shall not perform any of the duties of a preceptor.

5. NOTICE TO EMPLOYERS

Respondent shall notify all present and prospective employers of the Decision in this case and the terms, conditions, and restrictions imposed on respondent by the Decision in this case. Within thirty (30) days of the effective date of this Decision and within fifteen (15) days of respondent undertaking new employment, respondent shall cause his/her employer to report to the Board in writing, acknowledging the employer has read the Accusation and Decision in this case and understands respondent's terms and conditions of probation. Relief veterinarians notify employers immediately.

6. NOTICE TO EMPLOYEES.

Respondent shall, upon or before the effective date of this Decision, post or circulate a notice which actually recites the offenses for which respondent has been disciplined and the terms

and conditions of probation, to all veterinary and animal health technician employees, and to any preceptor, intern, or extern involved in his/her veterinary practice. Within fifteen (15) days of the effective date of this Decision, respondent shall cause his/her employees to report to the Board in writing, acknowledging the employees have read the Accusation and Decision in the case and understand respondent's terms and conditions of probation. Relief veterinarians notify employees immediately.

7. POSTED NOTICE OF SUSPENSION

If suspension is ordered, respondent shall post a notice of the Board's Order of Suspension, in a place clearly visible to the public. Said notice, provided by the Board, shall remain so posted during the entire period of actual suspension.

8. TOLLING OF PROBATION

If respondent resides out of state upon effective date of the decision, he or she must comply with the following conditions only: quarterly reports and interviews, tolling of probation, continuing education and cost recovery. If respondent returns to California he or she must comply or be subject to all probationary conditions for the period of probation.

Respondent, during probation, shall engage in the practice of Veterinary Medicine in California for a minimum of 24 hours per week for six (6) consecutive months or as determined by the Board. Should respondent fail to engage in the practice of Veterinary Medicine in California as set forth above, the time outside of the practice shall not apply to reduction of the probationary terms.

9. VIOLATION OF PROBATION

If respondent violates probation in any respect, the Board, after giving respondent notice and the opportunity to be heard, may revoke probation and carry out the disciplinary order that was stayed. If an accusation or petition to revoke probation is filed against respondent during probation, or if the Attorney General's office has been requested to prepare any disciplinary action against respondent's license, the Board shall have continuing jurisdiction until the matter is final, and the period of probation shall be extended until the matter is final.

10. COMPLETION OF PROBATION

Upon successful completion of probation, respondent's license will be fully restored.

11. COST RECOVERY AND PAYMENT OF FINES

Pursuant to Section 125.3 of the California Business and Professions Code, within thirty (30) days of the effective date of this decision, respondent shall pay to the Board its enforcement costs including investigation, hearing, and probationary monitoring in the amount of \$2,260 or the respondent shall make said payments as directed by the Board. FAILURE TO PAY THIS AMOUNT TO THE BOARD SHALL RESULT IN AUTOMATIC REVOCATION

OF THE LICENSE FORTHWITH, WITHOUT FURTHER NOTICE OR AN OPPORTUNITY TO BE HEARD.

12. ACTUAL SUSPENSION - INDIVIDUAL LICENSE

As part of probation, respondent is suspended from the practice of veterinary medicine for 60 days, beginning the effective date of this Decision.

During said suspension, respondent shall not enter any veterinary hospital which is licensed by the Board. Additionally, respondent shall not manage, administer, or be a consultant to any veterinary hospital or any veterinarian during the period of actual suspension and shall not engage in any veterinary-related service or activity.

13. SUPERVISED PRACTICE

Respondent shall practice only under the supervision of a veterinarian approved by the Board. The supervision directed may be continuous supervision, substantial supervision, partial supervision, or supervision by daily review, as deemed necessary by the Board. All costs involved with practice supervision shall be borne by respondent.

Within thirty (30) days of the effective date of the Decision, respondent shall have his/her supervisor submit a report to the Board in writing stating the supervisor has read the Decision in Case Number AV 2011 35, OAH Number 2011100467. Should respondent change employment, respondent shall have his/her new supervisor, within fifteen (15) days after employment commences, submit a report to the Board in writing stating the supervisor has read the Decision in Case Number AV 2011 35, OAH Number 2011100467.

Respondent's supervisor shall, on a basis to be determined by the Board, review and evaluate all or a designated portion of patient records of those patients for whom respondent provides treatment or consultation during the period of supervised practice. The supervisor shall

1) review these records to assess the medical necessity and appropriateness of respondent's treatment;

2) respondent's compliance with community standards of practice in the diagnosis and treatment of animal patients;

3) respondent's maintenance of necessary and appropriateness of respondent's treatment;

4) respondent's maintenance of necessary and appropriate records and chart entries; and

5) respondent's compliance with existing statutes and regulation governing the practice of veterinary medicine.

Respondent's supervisor shall file monthly reports with the Board. These reports shall be in a form designated by the Board and shall include a narrative section where the supervisor provides his/her conclusions and opinions concerning the issues described above and the

basis for his/her conclusions and opinions. Additionally, the supervisor shall maintain and submit with his/her monthly reports a log designating the patient charts reviewed, the date(s) of service reviewed, and the date upon which the review occurred.

If respondent is an employee rather a veterinary hospital owner, the supervisor shall additionally notify the Board of the dates and locations of all employment of respondent, during each month covered by his/her report.

14. NO OWNERSHIP

Respondent shall not have any legal or beneficial interest in any business, firm, partnership, or corporation currently or hereinafter licensed by the Board and shall not own any veterinary hospital.

15. NO MANAGEMENT OR ADMINISTRATION

Respondent shall not manage or be the administrator of any veterinary hospital.

16. PSYCHOTHERAPY

Within thirty (30) days of the effective date of this Decision, respondent shall submit to the Board, for its prior approval, the name and qualifications of one of more psychotherapists of respondent's choice. Upon approval, respondent shall undergo and continue treatment until the Board deems that no further psychotherapy is necessary. Respondent shall have the treating psychotherapist submit quarterly status reports to the Board. The Board may require respondent to undergo psychiatric evaluations by a Board-appointed psychiatrist. All costs shall be borne by respondent.

17. REHABILITATION PROGRAM - ALCOHOL OR DRUG

Within thirty (30) days of the effective date of this Decision, respondent shall submit in writing an alcohol rehabilitation program in which respondent shall participate (for the duration of probation) to the Board for its prior approval. In the quarterly written reports to the Board, respondent shall provide documentary evidence of continuing satisfactory participation in this program. All costs shall be borne by respondent.

18. SUBMIT BIOLOGICAL FLUID SAMPLES

Respondent shall immediately submit to biological fluid testing, at respondent's cost, upon request by the Board or its designee. There will be no confidentiality in test results; positive test results will be immediately reported to the Board and to respondent's current employer.

19. ABSTENTION FROM ALCOHOL USE

Respondent shall abstain completely from the use of alcoholic beverages.

20. FINE

Respondent shall pay to the Board a fine in the amount of \$2,000 pursuant to Business and Professions Code sections 4875 and 4883. Respondent shall make said payments as instructed by the Board.

Pursuant to Business and Professions Code Section 125.3, enforcement costs (investigative, legal and expert review), up to the time of the hearing, can be recovered.

21. ETHICAL TRAINING

Respondent shall take ethical training courses during the probationary period for a number of hours determined by the Board.
