Examination Updates

International Council for Veterinary Assessment (ICVA)

On <u>April 11, 2023</u>, ICVA announced Kerry Collins became a Society for Human Resource Management Certified Professional. The ICVA congratulated Ms. Collins on her recent certification.

On <u>May 10, 2023</u>, ICVA announced Dr. Courtney Vengrin, Senior Director of Assessment, recently completed the Fundamentals of Graphic Design certificate program through Emory University. In the program, Dr. Vengrin gained hands-on experience with various graphic design software programs.

On May 11, 2023, ICVA provided an updated on the ICVA Assessment Grant Program. The ICVA Academic Veterinary Assessment Committee, for the fifth year, announced its successful assessment grant program with up to three grant award opportunities of \$10,000 USD. The purpose of the grant is to validate current, discover new, implement, and support best practices in assessment veterinary medical education, including assessment of students, instructors, and programs. ICVA states proposals that demonstrate capacity in advancing knowledge of assessment practices/methods will be given priority and encourages faculty from accredited veterinary schools to apply for educational grants focusing on student assessment and feedback. Questions can be directed to ICVA. The deadline to submit a letter of intent was June 30, 2023.

On May 22, 2023, ICVA announced North American Veterinary Licensing Examination (NAVLE) results were made available to candidates that tested April 3-22, 2023. Instructions were provided on how to obtain examination results for those who tested and how to reapply for those who did not successfully pass the examination.

On May 26, 2023, ICVA announced Tonee McFarlane, who has been with the organization since 1998, took on an expanded role heading up ICVA Technical Operations while continuing in her current role as a Program Manager.

On June 7, 2023, ICVA provided an update on their Diversity, Equity, Inclusion, and Privilege (DEI-P) Task Force. The DEI-P Task Force initially met with ReadySet leadership in February 2023. ReadySet is conducting an organizational assessment to understand ICVA's current state. The information will be utilized to develop a DEI-P training plan, assist ICVA in building the DEI-P Task Force, and deliver a comprehensive DEI strategic plan and roadmap to the ICVA Board.

On <u>June 16, 2023</u>, ICVA announced Kent Hecker was selected for the Veterinary Education Group. Mr. Hecker will be working with other experts to refine and finalize credentialing and assessment processes for those within the realm of veterinary medical education.

Licensing Updates

Continuing Education (CE) Audits

Over the last fiscal year, the Board conducted 349 CE audits. Of those, roughly 27% were non-compliant. Depending on the severity of the non-compliance, the Board will be taking corrective measures, which could include educational letters, citations, or disciplinary actions.

Board Applications

Overall, the Board saw a slight (4%) decrease of total applications received compared to last fiscal year. This was predominately driven by the 40% decrease in veterinarian applications received. As previously discussed, the decrease in veterinarian applications was expected, since the Board combined two applications (examination application and licensure application) into one and eliminated the temporary veterinarian applications. University license, premises permit, and VACP applications all increased (68%, 15%, and 16% respectively), while RVT applications decreased by 3% compared to last fiscal year.

Licenses, Registrations, Permits Issued

In total, the Board issued roughly 13% more licenses, registrations, and permits than last fiscal year. While it appears the Board issued 12% less veterinarian licenses than last fiscal year, the prior fiscal year totals included temporary licenses. With the temporary license eliminated, effective January 1, 2021, the decrease in licenses issued was anticipated. When compared to last fiscal year, the Board issued the same amount of university licenses, and the number of RVTs, premises permits, and VACSPs issued all increased by 24%, 15% and 31%, respectively.
