AMERICAN VETERINARY CHIROPRACTIC ASSOCIATION (AVCA)

- A professional not-for-profit membership organization (established 1989) comprised of licensed doctors of veterinary medicine and licensed doctors of chiropractic
- Promotes animal chiropractic to professionals and the public
- Acts as the certifying agency for doctors who have undergone post-graduate animal chiropractic training
- Certification and membership are separate entities

ANIMAL CHIROPRACTIC CERTIFICATION COMMISSION (ACCC)

- An administratively independent certification body of the AVCA
- Implements and maintains a certification program that promotes quality in animal chiropractic
- Promotes the highest standards in animal chiropractic care for the protection and benefit of the patient as well as the public
- ACCC/AVCA is the primary national credential for this field in North America

WHAT IS CERTIFICATION

- Certification is a voluntary process by which a non-government entity grants a time-limited recognition and use of a credential to an individual after verifying that he/she has met predetermined and standardized criteria
- Certification is distinct from licensure in that it is voluntary and requires recertification to maintain the credential
- Certification in animal chiropractic was developed based upon input and oversight from both professions
- Certification establishes and promotes professional accountability and visibility
- Professional certification is different from a curriculum certificate program

DIFFERENCE BETWEEN PROFESSIONAL CERTIFICATION AND CURRICULUM CERTIFICATE

Professional Certification

- Non-governmental program
- Delivers an assessment based on industry knowledge
- Independent from training courses or course providers
- Grants a time-limited credential
- Examination is not used as a mirror, but as a screen, to separate those who meet the assessment standards from those who do not
- Primary focus is on assessment

Curriculum Certificate

- A non-degree granting program
- Purpose is to educate participants
- Course of instruction with intended learning outcomes
- Evaluates participants learning outcomes via an examination
- Awards curriculum certificate only to those who have passed that specific examination
- Primary focus is on education/training

PROFESSIONAL PRACTICE ANALYSIS (PPA)

- Purpose of conducting a practice analysis (a.k.a. job analysis or job task analysis) is to provide the foundation of a certification examination by defining practice in a profession
- Primary method used by assessment professionals to identify and prioritize the important tasks of a job or profession and the essential knowledge or skills required to perform the essential job functions satisfactorily
- ACCC/AVCA PPA
 - Currently under review by David Starmer, BSc (Hons), DC, MHS, Director of Education, Year III, Education Coordinator SIM Lab and research team at Canadian Memorial Chiropractic College (CMCC), Ontario
 - First completed in 2010, reviewed in 2016 and 2017, updated in 2018, Delphi process in 2011 to determine examination scope statement
 - Conducted by Douglas M. Lawson, DC, MSc, Psychometrician (University of Calgary, Faculty of Medicine, Medical Education Research Unit), Canadian Chiropractic Examining Board (1985-2003) and Mrs. Maria Lawson, Chief Executive Officer Canadian Chiropractic Examining Board (2003-2013), Alberta

CERTIFICATION EXAMINATION

- Purpose is to assure the public and the profession that candidates who pass are safe for practice in the field of animal chiropractic
- Strive to meet standards set by the American Psychological Association
- Professional Practice Analysis is examination blueprint
- Current and valid standards provide reliable indicators of competence and safety for the protection and benefit of the public

- Consists of written and practical components
 - Written examination designed to test clinical abilities, as well as knowledge
 - Practical examination designed to test the candidate's performance in a clinical setting to safely adjust
- Examination under continuous review and refinement

ACCC/AVCA CERTIFIED DOCTORS

- Licensed doctor of veterinary medicine or a licensed doctor of chiropractic
- Successfully completed an AVCA approved postgraduate basic animal chiropractic program
- Passed the ACCC/AVCA certification examinations
- Certificants are required to practice animal chiropractic within the laws and regulations of their individual states/provinces
- Recertification is required to maintain the credential
 - Continued competence demonstrates knowledge, skills, or ability to proficiently perform in the profession throughout the certificant's professional career

OVERVIEW

- AVCA is pleased to contribute educational and helpful information to state boards/licensing agencies
- AVCA has seen numerous approaches to appropriately regulating the practice of animal chiropractic
 - AVCA feels that it starts with educated, safe, ethical and professional practitioners
- Certificants are required to practice within the laws and regulations of their individual state/provincial boards/regulatory bodies
- ACCC/AVCA certification requires continuing education hours to maintain certification

- ACCC/AVCA abides by certification industry best practices
 - Certification is separate from membership
 - No certification reciprocity
 - Grandfathering is specifically prohibited in accreditation programs for certification organizations
 - o no two certification programs are identical
- ACCC/AVCA shares a common purpose with the veterinary and chiropractic boards
 - to promote and promulgate the practice of our individual professions
 - to protect the public from those who do not have the necessary knowledge or training to practice
