Examination Updates

International Council for Veterinary Assessment (ICVA)

The ICVA administers the North American Veterinary Licensing Examination (NAVLE). ICVA's mission is to provide world-class examinations and other assessment tools to protect the public, and animal health and welfare.

Since the last Board meeting, ICVA has disseminated the following announcements:

NAVLE Retake Policy Changes Effective December 1, 2025

ICVA informed NAVLE candidates of a change to its retake policy effective with the March 2026 testing window. The update will grant all candidates five new opportunities to retake the NAVLE, regardless of their prior testing history. Test attempts made before December 1, 2025, will not count toward the new five attempt limit.

ICVA announced elimination of the waiver process. As a result, any open waiver requests will be voided. More information is available on [ICVA's NAVLE Retake Policy FAQ](#).

ICVA Statement on NAVLE Independent Audit

ICVA issued a statement regarding its commitment to ensuring all members of the veterinary community feel confident in the exam's rigor and impartiality. The statement acknowledged questions raised by members of the community around the development, administration, and scoring of the NAVLE.

ICVA announced their decision to have an independent third party audit the examination. The process is in its early stages and ICVA will continue to update the community.

American Association of State Boards (AAVSB) Announcements

The AAVSB administers the Veterinary Technician National Examination (VTNE). The AAVSB's mission is AAVSB's leadership and comprehensive resources support and advance veterinary medicine regulation.

2025 Annual Meeting and Conference

AAVSB provided an update on its 2025 Annual Meeting and Conference held in Cincinnati, OH. The event featured committee meetings, elections for AAVSB leadership positions, and voting on bylaws, resolutions, and model documents. Congratulations to Dr. Bradbury, who was elected Director during the event.

AAVSB announced its 2026 Annual Meeting and Conference will be held September 22-26, 2026, in Providence, RI.

New Bill Allows 529 Plan to Pay for VTNE

AAVSB announced the *Freedom to Invest in Tomorrow's Workforce Act* passed in summer 2025 can be used for qualifying expenses related to the VTNE. AAVSB stated the change reflects the growing recognition of the vital role credentialed veterinary technicians play in animal health and welfare.

Veterinary Professional Association FAQ

In November 2024, [Proposition 129](#) passed in Colorado, establishing the Veterinary Professional Associate (VPA) role. AAVSB provided a timeline of events leading up to its involvement with the creation of the VPA along with an FAQ section.

Licensure Data by Jurisdiction

During the 2025 Annual Meeting and Conference, the AAVSB adopted [Resolution 2025-2](#).

AAVSB provided a map of and alphabetized list of participating jurisdictions.

Licensing Updates

Board Applications Received

Through Quarter 2 (Q2) Fiscal Year (FY) 25/26, the Board received a total of 1,846 applications across all license types. Comparing to Q2 FY 24/25, the Board received 142 less applications.

The number of veterinarian applications received during the reporting period saw no significant deviation with 300 received through in Q2 FY 25/26 compared to 294 through Q2 FY 24/25. The Board received approximately 100 less of each registered veterinary technicians (RVT) and veterinary assistance controlled substance (VACS) permit applications comparing data through Q2 from the FYs.

Licenses, Registrations, and Permits Issued

The Board issued a total of 1,610 licenses, permits, and registrations through Q2 FY 25/26. That represents a decrease in issued licenses, registrations, and permits by 195 comparing data through Q2 FY 24/25.

Comparing individual license, registration, and permit data from Q2 FY 25/26 to Q2 FY 24/25, the Board issued slightly more veterinarian (330 compared to 321) licenses and veterinary premises registrations (163 compared to 133). However, the Board issued less RVT registrations (352 compared to 430) and VACS permits (752 compared to 906).

Applications Pending

At the beginning of FY 25/26, the Board had 584 total paid applications pending and there are currently 579 paid applications pending. Compared to the number of applications pending at the end of Q2 FY 24/25, the Board's number of pending applications decreased by 227.

License Population

The Board's total license population continues to grow. The license population increased to 48,417 during Q2 FY 25/26 compared to 47,076 at the conclusion of Q2 FY 24/25.
